## PRIVACY POLICY

**Zinexts Life Science Corp.** ("Zinexts" "we," "our," and/or "us") values the privacy of individuals who use our websites, platform and related services (collectively, our "Services"). This privacy policy (the "Privacy Policy") explains how we collect, use, and share information from users of our Services ("Users"). By using our Services, you agree to the collection, use, disclosure, and procedures this Privacy Policy describes.

### 1 Information we collect

We may collect a variety of information from or about you or your devices from various sources, as described below.

# 1.1 Information you provide to us

The use of your information following any of these events will be governed by the provisions of this Privacy Policy in effect at the time the applicable information was collected.

**Consent**: We may also disclose your information with your permission.
